Chamber Singers: PR: C.I. A chamber choir of advanced singers. Open to all students by audition. Additional rehearsals and commitments required. May be repeated for credit. Fall, Spring. M&S fee \$20.00

### **Purpose of Course**

The choral organizations at UCF offer an opportunity to study and perform a variety of choral music of many styles, contexts and cultures, including classical masterworks with instruments and art and folk music of many traditions. Choral ensemble experiences encourage and reinforce healthy singing technique, provide an awareness of cultural and historical style, tradition and context, refine critical listening and reading skills, encourage analytical thinking through analysis-in-practice, and provide a community of musicians an opportunity to explore together the power of shared music-making.

### **Goals**

- Development of a beautiful and communicative ensemble sound
- Development of individual vocal technique
- Exploration of important repertoire for women's voices
- Performances sung from memory
- Cultivation of an ethos of excellence

### **Objectives**

- Students will develop consistent vocal technique and expressive singing skills through the study and performance of a stylistically diverse repertoire. (vocal skill development)
- Students will develop discriminating listening skills with regard to ensemble singing, balance, blend, timbre, diction, pitch, rhythm, harmony (aural skill development)
- Students will develop an awareness of and sensitivity to stylistic aspects of western and non-western traditions. (cultural/historical perspective)
- Students will experience and evaluate a variety of music and performance with regard to expressive qualities, interpretation, and musical/emotional effect. (aesthetic judgment)
- Students will diagnose technical and musical problems encountered in rehearsal and prescribe solutions. (analytical thinking and problem solving)

**As of Fall 2014, all faculty members are required to document students' academic activity at the beginning of each course. In order to document that you began this course, please complete the following academic activity by the end of the first week of classes, or as soon as possible after**

**adding the course, but no later than January 10th. Failure to do so will result in a delay in the disbursement of your financial aid. The academic activity is attendance and participation at rehearsal on Monday, January 6<sup>th</sup> and/or on roster by January 10<sup>th</sup>.**

### **Attendance, Punctuality, and Participation**

Attendance at all daily rehearsals, sectional rehearsals, retreats, dress rehearsals, and concerts is critical during a regular season. Other factors including attentiveness, preparedness, and effort are important in every rehearsal setting. However, this will not be a regular season, and I'm not going to tie attendance to your grade as in the past.

Attendance will be taken at the beginning of each rehearsal in order for Dr. Redding to check in with you. Communication is key! Just let Dr. Redding know if you're going to be absent.

### **If you are healthy and coming to a F2F rehearsal: Student Rehearsal Expectations:**

- Arrive on time and demonstrate professional courtesy by not leaving the rehearsal room once the rehearsal is in progress. (example: Use the restroom BEFORE class begins.)
- Arrive with individual music prepared.
- Bring your music.
- Have *and use* a pencil.
- Observe proper rehearsal etiquette by limiting talking and maintaining focus.
- Stay on top of your absences – communicate!!

**Please note: The rehearsal is a cell-free and portable device-free zone. Please turn off or silence them before each class. Texting is not allowed during rehearsals and performances. Do not bring phones into the performance space.**

### **Required Texts, Music and Folders**

Students enrolled in performing ensembles pay a nominal materials fee, which entitles them to use choral scores owned by the department. You are responsible for the folder and all music assigned to you on loan and assessed for any music that is lost or damaged.

**There will be NO formal Concert Dress or Tuxedo for this semester! However, the tuxedos will be changing in the future (We going to tuxedos with tails.)**

### **Diversity**

<p><b>Children in Virtual Sessions</b></p>	<p><i>The following statement about children in virtual classes was provided to us as an additional resource by faculty member Elizabeth Horn and was adapted from <a href="#">language at Oregon State University</a>. It is not an officially required or optional statement from the university. However, we think it’s one great way of acknowledging one of the myriads of challenges our students face at this time.</i></p> <p><b>Statement</b></p> <p>Parents deserve access to education. At all times, I strive to be inclusive to parents, and now, in our virtual learning space, with many children learning from home or schools facing sudden closures, we can expect children to be present in class from time to time.</p> <ol style="list-style-type: none"> <li>1. All breastfeeding babies are welcome in our synchronous sessions as often as is necessary to support the breastfeeding relationship. I never want students to feel like they have to choose between feeding their baby or continuing their education.</li> </ol>

	<ol style="list-style-type: none"> <li>2. Children may be visible onscreen during class sessions, either in your lap or playing in the background. Alternatively, you may turn your camera off if more privacy is required.</li> <li>3. Parents or caregivers who anticipate having a child(ren) with them during class sessions are encouraged to wear a headset to help minimize background noise. You may mute your microphone and communicate through the “chat” feature at any point necessary.</li> <li>4. Stepping away momentarily for childcare reasons is completely understandable and expected. Simply mute and/or turn off your camera as necessary, and rejoin us when you are able.</li> <li>5. I ask that all students work with me to create a welcoming environment that is respectful of all forms of diversity, including diversity in parenting status.</li> <li>6. I hope that you will feel comfortable disclosing your student-parent status to me. This is the first step in my being able to accommodate any special needs that arise. While I maintain the same high expectations for all student in my classes regardless of parenting status, I am happy to problem solve with you in a way that makes you feel supported as you strive for school-parenting balance.</li> </ol>
